1. Offers

Our offers are non-binding, the last offer cancels all previous offers. Due to the limited quantities of individual vintages, a sell-out situation may occur during your order.

Availability subject to change!

We reserve the right to shorten orders without giving reasons in order to enable all customers to purchase our wines. Only our current terms of delivery and payment apply to the delivery.

Deviating agreements are only valid if they are confirmed by us in writing.

2. Due date

The order is validly concluded upon confirmation of the order (by e-mail or letter) by us. We are entitled to withdraw from the contract in the event of typing, printing or calculation errors on the website.

3. Delivery

For shipments within Austria we charge shipping costs of € 7,-- per box of 6 and € 10,-- per box of 12.

For shipments to Germany, the shipping costs charged are € 14.00 per box of 6 and € 17.00 per box of 12.

From an order value of \in 100,- no shipping costs will be charged. Orders from other countries will be processed separately.

4. Transport damage

For damages and impairments that occur during transport, we guarantee full compensation under the following conditions.

Replacement under the following conditions:

- The incoming goods must be checked immediately for correctness and completeness.
- Complaints about the goods must be reported within 8 days.
- Any complaints must be confirmed by the transport company.

5. Reservations

The delivered goods remain our property until full payment has been made. Transfer of ownership and seizure are inadmissible until payment has been made. The buyer is obliged to inform us of any seizure.

6. Payment

We reserve the right to demand payment in advance from new customers.

Wine deliveries ordered via our online shop can be paid on account (existing customers), by prepayment, credit card or instant bank transfer.

The ordered goods must be paid promptly after receipt of the invoice without deduction. In the event of late payment we charge 12 % p.a. interest on arrears.

7. Prices

Prices are quoted in euros per bottle, including all statutory duties and taxes (VAT), excluding transport costs, which are to be paid separately.

Prices are subject to change and errors excepted!

8. Warranty

In accordance with customary international practice, no replacement can be provided for corked wines. Goods can be returned within 1 month, if they have not yet been opened, at the buyer's expense. Alcoholic beverages are only sold to persons over the age of 18.

Any invalidity of individual provisions shall not affect the validity of the remaining provisions.

9. Place of jurisdiction

The place of fulfilment is Andau. For all legal disputes, the contracting parties submit to the jurisdiction of the District Court of Neusiedl am See regardless of the amount in dispute.
